1.0 CALL TO ORDER, NATIONAL ANTHEM AND WELCOME

Chair Dirks called the meeting to order at 5:00 p.m. and the Bowness High School Choral 10-20-30 students led in the singing of the national anthem by way of a pre-recorded DVD. Chair Dirks welcomed representatives from the aforementioned organizations and members of the public. He also introduced and welcomed Sean who is a Board Page for the 2006-2007 school year.

3.0 SCHOOL/SYSTEM PRESENTATIONS

3.1 <u>Douglas Harkness Community School</u>

Superintendent Drysdale provided introductions and noted that Douglas Harkness Community School won the national video competition for racism in the "Stop It" campaign sponsored by the Minister of Canadian Heritage and the Status of Women. The students from Douglas Harkness Community School were the youngest group to enter this competition and to win.

Ms. L. Kinsman, Principal, shared comments about the work at the school, noting that much of it is focused on Ends 3 – Citizenship, and to a great extent the work is about building peaceful communities together. Seventy percent of the students at Douglas Harkness Community School are English as a Second Language and a strong focus of the learning for the school's multi-literacy students is through the fine arts and technology programs. Ms. Kinsman noted that the students' work on their video exemplifies their confidence in working together as a team, and the strengths they gained in verbal skills and leadership. The students' racism video was shown and Mr. M. Scullion, Technology Lead Teacher, gave remarks about the students' learning through technology. The following students came forward and shared comments about racism: Kyle, Harmeet, Sirine, Taylor, Omar, Salim and Somira.

On behalf of the Board of Trustees, Trustee Fawcett thanked the presenters for the presentation and congratulated the students on their success with their video on racism.

5.1 Correspondence

Chair Dirks read the contents of a letter received from The Honourable Monte Solberg, Minister of Citizenship and Immigration Canada (CIC), that was received in response to the Board's expressed interest in having the Settlement Workers in Schools (SWIS) initiative introduced into Calgary schools, and the letter indicates that CIC will be expanding inschool support activities to more communities across Canada.

5.2 REPORT FROM THE CHAIR AND TRUSTEES

Trustee Cochrane shared comments about a celebration that was held in early July at Stanley Jones School. Stanley Jones School has three separate programs operating out of its building, including the Regular program, the Deaf and Hard of Hearing program, and Alice Jamieson Girls' Academy, and all of its students have undertaken a partnership project with two schools in Ghana, West Africa. A celebration was held in acknowledgement of this partnership and attendees of the celebration included three tribal Chiefs from Ghana, Deputy Chief Superintendent Hubert and Trustee Cochrane.

On behalf of the Board of Trustees, Chair Dirks expressed a special word of welcome to our 100,000 students as they head back to school for the fall, and to all teaching staff, support staff, parents and the CBE administration, wishes for a very successful year of education. He also expressed congratulatory remarks to those communities which have new schools opening this fall, and to those that will be opening in the 2006-2007 school year.

5.3 Report from the Chief Superintendent

Chief Superintendent Croskery shared words of appreciation to CBE staff for their work over the summer months; and he noted that our teaching staff and administrators were in schools long before the re-opening of schools, working to get the school year started.

Chief Superintendent Croskery noted that he and Deputy Chief Superintendent Hubert met earlier in the day with a delegation from the Department of Foreign Affairs, The People's Government of Zhejian Province in China, who are very interested in Canadian education and are visiting select school divisions in Canada.
