Vaccination Requirement for Employees, Partners, and Volunteers

With support from the Board of Trustees, the CBE has made the decision to require that all employees, volunteers and CBE partners be fully vaccinated against COVID-19 by **Friday, Dec. 17**.

While we also encourage eligible students to be vaccinated, it is not a CBE requirement.

Health authorities state that vaccination is one of the most effective ways of reducing COVID-19 transmission. The CBE Board of Trustees advocated for a provincial vaccine mandate for education sector staff in a [Sept. 17 letter to the Minister of Education](#) in response to division and parent concerns over COVID-19 in our schools.

Additionally, the province has released [new health guidelines](#) and updated the [Alberta Health Daily Checklist](#). This includes new direction if there is a positive COVID case in your household and your child is not fully immunized.

ASCA Online Learning Resources

In the new reality of online delivery, Alberta School Councils' Association (ASCA) has increased digital resources, virtual interactions and opportunities for school councils to utilize in operations.

ASCA has restructured delivery of services, workshops and supports by offering online learning resources for school councils.

ASCA hosts [Meeting Mondays](#) – online engagements, creating a forum for school council parents to learn, share information, and support each other.

[Webinar Wednesdays](#) present interactive online training sessions, focused on topic areas specific to the work of school councils.

Informative web clips –(shorter, distinct information; 2 to 5 minute videos) and webcasts (longer information videos; 5 to 10 minutes in length) with a beneficial range of topics have been developed to assist school councils.

Web clip topics include *School Councils and School Re-entry*, *Hosting a Virtual School Council Annual General Meeting (AGM)*, and *School Council Election Process*.

Call for Advocacy Resolutions AGM 2022

2021 School Re-entry Plans Survey

The ASCA Board of Directors sincerely thanks the 11,133 Albertans who participated in the survey to gather feedback on the 2021-2022 School Year Plan announced by Education Minister Adriana LaGrange on Aug. 13, 2021.

Representing every school choice in Alberta, 9,128 parents, 936 grandparents, 158 caregivers and 145 guardians of students in grades K-12 from approximately 400 towns/cities across Alberta shared their opinions through the survey. Over 50 expanded on their survey responses through emails and letters directly to, or shared with, ASCA.

ASCA received multiple comments on the integrity of the survey. Some respondents felt the questions were biased; other respondents felt the questions were too direct – not allowing for articulation of partial support or providing reasonings for specific responses. ASCA acknowledges, in retrospect, that the simplicity of the questions asked in relation to the complexity of potential perspectives was not ideal.

ASCA believes the structure of the survey caused the responses for all 10 questions to have very small variances of yes/no perspectives, rendering the overall results to be inconclusive in terms of what the majority of Alberta's parents support within the 2021-2022 School Year Plan.

Because of this, ASCA will not release or publish the results of the survey, and commits to providing opportunities for more meaningful, detailed perspectives in the future.

Related to the 2021-22 School Year Plan, the ASCA Board will communicate to the Minister of Education, education stakeholders, and partners, the Association's belief that public health policy must be established by public health officials and experts, and not left to education experts such as trustees, superintendents, and others.

ASCA will also advocate for:

- the continuation of mandatory isolation for positive cases beyond Sept. 27, 2021;
- the continuation of testing beyond Sept. 27, 2021;
- the continuation of provincially overseen contact tracing beyond Sept. 27, 2021;
- the implementation of mandatory reporting of positive cases to schools; and
- the requirement of schools to notify close contacts of positive cases so that parents can make informed decisions regarding their own children's risks while attending in person learning.
