### **Calgary Transit Access Travel Training Summer Camp 2019**

Sponsored by Calgary Transit, Calgary Catholic School District and Calgary Board of Education

The 'Get on Board' Travel Training Summer Camp will aim to teach participants with disabilities how to ride on public transit. It will provide both classroom and bus/CTrain training. In order to ensure that this camp is right for you and your child please refer to the qualifications list below which outlines who would benefit most from this camp:

#### **Preferred Qualifications:**

- Have a mild to moderate disability.
- Be between the ages of 11 - 18.
- Be unfamiliar with riding Calgary Transit independently; some exposure is acceptable.
- Be self-sufficient in course work or attend with an aide.
- Attend the camp to gain sufficient knowledge to take Calgary Transit independently upon the conclusion of the program or specific goals should be submitted in the application form.
- Have the ability to recognize some words related to Calgary Transit. For example, help button, station, numbers, etc.
