- ii) shall serve in an advisory capacity to the Board of Trustees of the Calgary Board of Education and ensure that the Board of Trustees of the Calgary Board of Education is fully informed, in a timely manner, of the business conducted at TEBA meetings; and
- iii) is not authorized to make decisions that are the purview of the Board of Trustees; and

THAT the Board of Trustees authorizes the communication of this decision to the appropriate Alberta Education representatives as required.
