#### RE: New CBE Schools - Griffith Woods School and Ron Southern School

Opening our new schools is a top priority for the Calgary Board of Education (CBE), and we are working diligently to ensure that our new learning environments are ready for students for the 2017-18 school year.

Regrettably, the opening of Griffith Woods School will be delayed until January 2018 from its projected opening date of Sept. 5, 2017. Griffith Woods School will serve kindergarten to Grade 9 students from the communities of Springbank Hill and Discovery Ridge.

The opening of Ron Southern School will also be delayed. We will confirm an opening date for this school in September 2017. Ron Southern School is a kindergarten-Gr. 6 school in the community of Silverado.

Contingency plans for both schools have been developed and will be shared with parents on April 12, 2017 as part of our commitment to keeping them informed. Students will temporarily be housed at existing schools until their new school is ready to open. To minimize transitions for students, they will operate using our "school within a school" model. Wherever possible, students may attend classes with the classmates and teachers they will have at the new school.

Delays at both schools are the result of extremely ambitious timelines that were further impacted by an unusually wet summer in 2016 coupled with a colder than average winter. The opening dates, established by Alberta Infrastructure when these schools were originally announced, were selected prior the development of project schedules. Based on our experience of building 18 new schools during the 16/17 school year, the construction times for Griffith Woods School and Ron Southern School were several months less than the average construction times for schools with 900 and 600 student

capacities respectively. The delay at Ron Southern was also impacted by site related issues encountered at the very outset of the project.

The CBE is working with the prime consultants, project managers and general contractors on these projects to accelerate construction schedules where possible. We are committed to opening quality schools that are well built to serve the needs of students and communities for many years to come.

We will continue to keep you and our communities updated as new information becomes available. Information on the delays and the contingency plans will be posted on the CBE website and the schools' websites.

#### 2 I Issue

As the Board of Trustees' chief executive officer, the Chief Superintendent is accountable for meeting the expectations set by the Board. These expectations are stated in Results and Operational Expectations policies.

OE-8: Communication With and Support for the Board requires that "the Board is supported in its work and is fully and adequately informed about matters relating to Board work and significant organizational concern." With other reports submitted to the Board of Trustees, this update meets the requirement of OE-8 for the provision of information in a timely, simple and concise form.

#### **Personalize Learning**

#### True Colours: Creative Arts Program

Throughout the week of April 24-28 CBE students from grade 1 to 12 with a visual impairment (low vision and those who use braille) participated in a program of adapted activities specifically designed to enhance students' experiences in areas of the creative arts held at Mapleridge School. Students experienced dance, music and art with a hands-on, multi-sensory approach. The week's activities concluded with a Celebration of Learning. This program was an important event to extend each student's experiences with creative arts and develop as unique learners from interactions with each other

#### **CBE Workshop and Pow Wow**

Elder Reg Crowshoe, Turning Robe Drummers, and youth mentor Pow Wow dancers shared teachings with grade six to nine students in two half day workshops about the cultural significance and importance of drumming and dancing at Pow Wow at the first annual experiential Pow Wow Workshop.

People from many communities gathered on May 5th to celebrate the Calgary Board of Education's third annual Pow Wow at Crescent Heights High School. Traditional Pow Wows bring together people in celebration of culture, spiritual growth, dance, drumming and learning. Blackfoot Elder Reg Crowshoe began the celebration in a traditional way by offering a blessing followed by a feast and Grand Entry. Host drum, Turning Robe Drummers, and emcee Hal Eagletail provided entertainment and teachings throughout the evening.

#### Student Voice Design Challenge 2017

On Wednesday, May 3 the Student Voice Design Challenge was held. In total 103 students, representing 38 different junior high, middle, and high schools, along with students from the Chief Superintendent's Student Advisory Councils were present and took part in one of three design challenges centered around the Results Statements: academic success, citizenship, personal development and character.

The Chief Superintendent's Council members felt strongly that the Results were essential to their learning to become thriving contributing citizens in their communities. The challenges were drawn from discussions and topics that were raised at the Advisory Council monthly meetings. The three design challenges were cell phone & social media use in schools, managing stress, and creating inclusive learning environments. Design challenges stem from an idea development strategy known as design thinking. Design thinking is a way of looking at challenges in a creative way.

Each of the three groups were led by a design leader (CBE Specialist in Learning) who took the students through a process to better understand the challenge,

identify potential solutions, prototype and finally pitch their idea. The process allowed students to work with peers they had never met in a collaborative, engaged and efficient manner to not only discuss concerns but to also come to solutions. This allowed students to further develop their skills to lead and follow as well as develop positive relationships with their peers, thus growing in the area of Personal Development.

#### **Build Professional Capital**

#### Designing for Artful Play

In collaboration with specialists from Design Thinking and Arts Education, Early Learning offered a series of 5 research-informed professional learning opportunities designed for early learning teachers (kindergarten and EDC). In these sessions learning was approached through studio habits of mind (studio thinking) and a play-based pedagogy. Studio habits of mind include: developing craft, engaging and persisting, envisioning, expressing, observing, reflecting, stretching and exploring, and understanding community. Teachers learned about play-based instructional design that encompasses learning through visual arts, music, drama, dance and the land. They engaged in the process of creative development as a way to enhance their pedagogy with artists, with art, and with art making in authentic venues. They were immersed in disciplinary ways of knowing, being and doing.

The results of this professional learning have been:

- personalization of learning, including active and effortful tasks designed for student interests and learning needs;
- increased student agency and intellectual engagement;
- enhanced professional capital;
- engagement of stakeholders (artists and art venues);
- joyful learning!

#### Assessment and Languages

The principals of schools with bilingual programs requested a common Professional Learning (PL) day highlighting formative assessment. The PL day was in response to school-based data analysis and Professional Learning Community (PLC) conversations.

Principals and Learning Specialists designed this learning opportunity to address three main areas: personalized learning through formative assessment, leadership for learning and determining achievement and reporting.

The concept of formative assessment was addressed through a session presented by Dr. Dylan Wiliam based on his research published in: "Embedding Formative Assessment". Leadership for teacher learning was emphasized in a second session from Dr. Wiliam offered to administrators, learning leaders and teachers interested in leadership roles. This session concentrated on the importance of establishing effective professional learning communities that focus on the continuous improvement of pedagogical practices. A final block of sessions was

designed to host conversations about the CBE Guiding Principles for Assessment and Reporting. These sessions were discipline-based and addressed the importance of intentionally generating a body of evidence that informs reporting of students' most consistent, recent pattern of performance in relation to course outcomes.

Bilingual schools are committed to further developing their work in assessment by maintaining PLC conversations and planning cross-school PLCs in pursuit of a coherent approach to formative assessment and reporting practices. This work will continue to be a common goal for bilingual schools in order to support their individual School Development Plans and the CBE's Three Year Education Plan.

#### Knowledge and Employability Community of Practice

This year three meetings for the interdisciplinary Knowledge and Employability Professional Learning Network (K&E PLN) occurred. The first PLN was held on November 18, 2016. The Learning Specialists involved in the network have been intentional about responding to the feedback gathered at each session in order to design the PLNs in response to teacher needs and student learning.

The second K&E PLN was held on March 3, 2017. Participants engaged in a conversation about student learning plans. They also discussed some "K&E Myth-busters" to develop common understandings around enrolment, special education and learning experiences. They then explored the philosophy of a K&E program of study to find commonalities and big ideas. Teachers had the opportunity to learn from each other and share tasks, resources and ideas.

The final K&E PLN was held on May 5, 2017. The focus was on math tasks that integrate specific outcomes from both the regular Grade 9 and the K&E Grade 9 programs of study. Teachers examined the learning tasks through the lens of the philosophy of the K&E Math Program of Studies and discussed how the richness of the discipline supports student learning in a blended classroom model. A brochure on K&E courses is being designed by a team of Learning Specialists in collaboration with Communications. The purpose of the brochure is to support families in making informed decisions about enrolment in K&E courses. Feedback from teachers was gathered at the final PLN to strengthen the content and layout of the brochure.

#### **Engage Our Public**

#### Cinderella Program

March 11, 2017 was the thirteenth annual Cinderella Event for the CBE. Over 330 students from 42 high schools were invited to participate. Thanks to the help of over 250 volunteers, the Cinderella project not only provided students in need with graduation essentials, but also enhanced the relationships and nurturing needed to create conditions for success for each participant. With over 50 CBE staff members volunteering their time, the event day fostered relationships beyond classrooms and honoured the achievements of each attendee. This is evident by the feedback provided by a parent from this year's event:

#### Listening to our City

On April 21<sup>st</sup>, Calgary Board of Education students captivated their audience through an exceptional evening of music and dance at *Listening to our City*, a legacy from the 2016 JUNO Award's. *Listening to our City's* goal is to connect youth with the musical community, to showcase their strengths and talents and to offer them an opportunity to perform on a professional stage.

With the generous support of the Calgary Stampede Foundation, students had a chance to perform individually, in small ensembles and with large collaborative performance groups in the Jack Singer Concert Hall at Arts Commons.

Highlights of the evening included dancers from Robert Thirsk High School, students performing within the MRU Conservatory Strings, MRU String Duet (students at Tom Baines and Earnest Manning), Alberta International Band Festival Honour Band, Young Canadians of the Calgary Stampede, Harry Knight, a nine year old flamenco guitarist (Collingwood School), and recognition of Kate Stevens, who created a student performance opportunity venture entitled YOMOMMA, which offers students performance opportunities through the year.

Listening to our City is an exemplary example of everyone contributing to the success of public education by personalizing learning for students and engaging as stakeholders.

#### Support your Teen with Career Exploration

A unique collaborative initiative between the Calgary Board of Education, Calgary Public Library (CPL) and Southern Alberta Institute of Technology (SAIT) is currently being planned. Two evening sessions will be held to provide parents with information on assisting their child in preparing for the world of work. Staff from CBE, CPL and SAIT will present and assist parents in understanding career and employment trends in the 21<sup>st</sup> century, explore models to assist their child in navigating career exploration, learn about career pathways, options and choices available at the middle/high school and post-secondary levels, and develop awareness of the resources and services available to support their child.

The two sessions will be held on May 25<sup>th</sup> at Fish Creek Library and May 29<sup>th</sup> at the Village Square Branch. Information on the sessions is being communicated through the *Library Connect Magazine* and through CBE communication channels.

This pilot initiative supports the Calgary Board of Education's Mission; each student, in keeping with his or her individual abilities and gifts will complete high school with a foundation of learning necessary to thrive in life, work and continued learning.

#### **Steward Our Resources**

#### Waste Reduction Strategy: Getting to 80%

The CBE has a considerable legacy of leadership and success in environmental education and energy management at both an individual school level and a system level. We strive to be a leader in sustainable practices and behaviours.

In 2013 the Calgary Board of Education (CBE) received a Calgary Award from the City of Calgary for the excellent work it had done in reducing its waste going to landfill by over 50%. However, to attain the CBE target of 80% waste reduction by 2020 a new and more personalized approach is required. Starting in April of this year, schools received an infographic that outlined the CBE average waste to landfill, the school's current waste to landfill profile and a target waste reduction objective that will result in an aggregated 80% reduction.

Schools currently pay for their own recycling, while waste removal is paid from CBE central funding. The new initiative rewards schools that produce less waste than the CBE average by covering all or a portion of their recycling costs from CBE central funding. Although the initiative is only just now being implemented, schools are already taking up the challenge and in so doing, are reducing the amount of waste produced while concurrently modeling the behaviour required of students to become responsible citizens who are conscientious stewards of the environment.

#### **Employee Contact Centre**

CBE has strategically determined to transition the HR Employee Contact Centre, currently outsourced to Telus Sourcing Solutions Inc. (TSSi), back into CBE. A Project Manager has been engaged; the project plan has been created; the CBE project team has been established; job postings have been scheduled; Staff Association has been updated and TSSi management have been formally notified. The planned go live date for the CBE operated Call Centre is July 31, 2017.

Board/Chief Superintendent Relationship: The Board defined in policy how authority is delegated to its only point of connection – the Chief Superintendent – and how the Chief Superintendent's performance will be evaluated.

Operational Expectations: These policies define both the nonnegotiable expectations and the clear boundaries within which the Chief Superintendent and staff must operate. They articulate the actions and decisions the Board would find either absolutely necessary or totally unacceptable.

Results: These are our statements of outcomes for each student in our district. The Results policies become the Chief Superintendent's and the organization's performance targets and form the basis for judging organization and Chief Superintendent performance.
