At the meeting, we will answer questions we heard at the December parent meeting and talk more about what the closure process would like over the next few months. We also want to hear from you about what is important to your family as we begin to consider where students could attend school in the future.

## **Background**

On Dec. 6, 2018, 21 parents attended a meeting at Rosscarrock School to hear about low enrolment at the school and what that might mean for the future, including the possibility of a recommendation for consideration of closure of the school. A <a href="presentation">presentation</a> from Calgary Board of Education (CBE) staff was followed by an opportunity for discussion and to ask questions.

At the time, Rosscarrock School had 105 students in the K-6 regular program, with only eight students enrolled in Grade 1. Since the parent meeting, enrolment at the school has declined even more.

CBE administration has decided to submit a recommendation for consideration of closure of Rosscarrock School to the Board of Trustees of the CBE in February. If the Board of Trustees approves the recommendation, the formal closure process as defined by the School Act and related regulations would begin.
