- Good idea to switch tables to get new perspectives.
- Most: The CBE people and general parents were all good.
- Least: Provides a venue for parents to vent without having any useful recognition of inputs that will make real changes.
- It was beneficial to learn about the strategy and that parents are involved in the next level.
- Please have these engagements so parents can be a part of this important subject.
- Learn other perspectives.
- I think the contention that "things are going great and we want to be better" doesn't really respect our concerns.
- Positive: parent engagement
- Negative: taking hiring and teacher qualifications off the table
- I felt that my thoughts are important.
- Most: Discussing and sharing math education issues with other people.
- Least: Concern with being the best at math rather than just enjoying math.
- The recorders missed out on some of the discussion. A volunteer can be used instead who is not a participant.
- They should have volunteers to record the ideas, as a recorder I missed a lot of the discussion.
- I filled out my purple sheet very glad to have this opportunity.
- Survey link didn't work well for me.
- Conversation was overtaken a bit. I am not shy to get involved but I didn't have to worry about getting my point across.
- I felt badly for staff that certain things comments at the beginning were overtaking the directionglad it got back on track.
- I disliked the groups. I think more thought should have been put into groupings rather than just mingling. I found once I sat down I could not believe the things I was hearing and I disagreed with but the loudest voices were the ones whose ideas got written down on paper.
- Ability to speak up and be heard.
- Most: Meeting with and talking to other parents.
- Least: lack of acknowledgment that something is broken in the CBE with math strategy. Lack of urgency. Sense that the CBE won't really take parental or external input seriously when planning future strategies.
- Like: Parents very engaged.
- Least: Core discussion should have been on <u>curriculum</u> not just classroom strategies. Feeling
 that the main problems will not be solved by CBE (curriculum). Parents want a say on curriculum
 level, not on classroom strategy.



- The engagement allowed for open communication and interaction with CBE representatives and parents. The engagement seems limited to the current issues that exist rather than accepting there are other major inherent problems within the education system.
- Dialogue was good.
- Need to understand why things are not working well. This was not discussed.
- Hearing the thoughts and opinions of other parents and how we are all on the same page.
- I did not like not being able to see the strategies being used at schools.
- To sit and talk with a variety of stakeholders, parents, a principal, teachers, Trustee King and system people. We need to hear one another's voices and not do this work in our own intellectual SILOS. Thank you!
- Discussion and CBE is open for changes
- Changing tables people to hear the most opinions not just one or two.
- The individuals from the consultant and CBE were, in the vast majority of cases, very helpful. An interventionist approach from them would skew results.
- We can share the idea about child's math. How they improve their math.
- I worry that this is a <u>pooling of opinion</u>. Experts actually know how to teach math. Their input should be strongly weighted. Let's build a strategy on research and fact, not current vague opinion.

- Least: audio (PA system) was distractingly poor.

- Positive: ability to share with parents. Having CBE members present for Q&A
- Negative: questions were not answered directly and with clarity I am not confident with CBE.

- Least: focus on "what" is being learned in math, and concerned that the strategy may not emphasize the "how" it is being learned, which seems to be what is raising the biggest concerns. Minimal confidence in some of the strategies being used in school, and realizing that even some teachers don't think it's the best approach.
